Required Documents

All documents must be submitted to commence the process with a notarized translation to English or Hebrew of all documents, and with an Affidavit as detailed below that has been certified in accordance with the Israeli Notaries Law, 5736 – 1976. This means (a) by an Israeli notary, (b) by an Israeli consul or (c) by a notary in the State where the certificate was given. In the third case, the document must be legalized as an Apostille (if the country is a member of the Hague Convention), or if not, legalized by that State and also by the Israeli consulate in that State. If these requirements are not fully met, THE APPLICATION WILL NOT BE PROCESSED:

1. ☐ Payment of Application fee in the amount of 549 NIS
2. ☐ Confirmation of passing the Israel Bar Association ethics examination.
3. ☐ An approval of the authorized body to grant a license to practice law in a Foreign Country that the Applicant has a valid license to practice law.
4. ☐ Evidence that the Applicant serves as a lawyer or served in a judicial position outside of Israel, for at least five years during the prior period.
5. ☐ Approval of an official body in the Foreign Country regarding the criminal past of the Applicant, including details regarding criminal convictions or pending criminal proceedings.
6. ☐ Approval of the body authorized to perform disciplinary proceedings for lawyers or those serving in a judicial position regarding disciplinary convictions, lack of them or pending disciplinary proceedings against the Applicant.
7. ☐ An affidavit by the applicant of all pending criminal and/or disciplinary affairs or lack of them against him outside of Israel.
8. ☐ Consent by the applicant in which he allows the IBA to obtain information from the Crimes Registry in Israel
9. ☐ Confirmation the applicant holds one of the securities according to section 98F (a) (4) of the law – to be submitted solely **after** a notice form the Israel Bar regarding all other requirements

Applicants originated from non-OECD countries must submit in addition documents as mentioned in section (2)(d) to the Rules of the Bar Association (Registration and Supervision over Foreign Attorneys and Fees), 5772 – 2012
